The Government of India has applied for financing in the amount of US\$ 230 million equivalent from the Asian Infrastructure Investment Bank (hereafter AIIB) towards the cost of the Extension Renovation and Modernization of Grand Anicut Canal System Project, and it intends to apply part of the proceeds to payments for goods, works, non-consulting services and consulting services to be procured under this project.

The Project will include the following components:

- **Component A:** Rehabilitation of Grand Anicut Canal system for a total length of 148.650 kms.
- **Component B:** Renovation and Reconstruction of cross drainage works and cross Masonry Works.
- **Component C:** Rehabilitation of Feeding tanks, Renovation/Reconstruction of Regulators.
- **Component D:** Design, Supply and Delivery and Installation of Automation and SCADA arrangements of the main canal with a provision for the extension of this SCADA arrangement for the Future expansion as required by the WRD.

Procurement of contracts financed by the AIIB will be conducted through the procedures as specified in the AIIB's Interim Operational Directives on Procurement Instruction for Recipient (June 2016), and is open to all eligible firms and individuals.
