ORDER:

During the Water Resources Department's Demand for Grants for the year 2021-2022 held on 23.08.2021, the Hon'ble Minister for Water Resources has announced on the floor of Assembly that "This Government demonstrated the emphasis it places on conserving and appropriately utilizing the limited water resources of the State by creating a new Ministry for Water Resources. To carry forward the vision of the Hon'ble Chief Minister, it is announced in the Budget that 1,000 check dams and barrages are planned to be constructed over the next 10 years."

- 2. Based on the above announcement, the Chief Engineer, Plan Formulation, Water Resources Department in his letter first read above, has sent a proposal for the Work of construction of 5 Nos. of Check Dams in Coimbatore Region for an amount of Rs.21.82 Crore and these Schemes envisages the following:
- I. Construction of a Check dam across the Nanganjiyar river in Velambadi Village of Aravakurichi Taluk in Karur District at an estimated amount of Rs. 5.45 Crore

The proposed Check dam site lies across the Nanganjiyar river in Velambadi village of Avarakurichi Taluk of Karur District, in Amaravathy Sub-basin of Cauvery basin. No patta land acquisition is required for this project.

II. Construction of a Checkdam across the Perumalkovil Odai in Athikombai Village of Oddanchatram Taluk in Dindigul District at an estimated amount of Rs.2.50 Crore

The proposed Check dam site lies across the Perumalkovil Odai in Athikombai village of Oddanchatram Taluk in Dindigul District, in Amaravathi Sub-basin of Cauvery basin. No land acquisition is involved in this scheme

III.Construction of a Check dam across the Chinna odai in Odaipatti village of Oddanchatram Taluk in Dindigul District at an estimated amount of Rs. 1.50 Crore

The proposed Check dam site lies across the Chinna odai in Odaipatti village of Oddanchatram taluk of Dindigul District, in Amaravathy Sub-basin of Cauvery basin. No patta land is required for this project.

IV. Construction of a Check dam across the Odai in S.F.No.195 near Kampathumadai in Arisipalayam Village in Madukkarai Taluk of Coimbatore District. at an estimated amount of Rs.2.00 Crore

The proposed Check dam site lies across the Odai in S.F.No.195 near Kampathumadai in Arisipalayam village in Madukkarai Taluk of Coimbatore District, in Walayar Sub-basin of Bharathapuzha basin.No patta land is required for this project.

V. Construction of a Check dam across the Amaravathy River at LS 93.00Km near kavundaiyanvalasu Village of Dharapuram Taluk of Thiruppur District at an estimated amount of Rs. 10.70 Crore

The proposed Check Dam site lies across the Amaravathy River at LS 93.00Km near kavundaiyanvalasu village of Dharapuram Taluk of Thiruppur District, in Amaravathi Sub-basin of Cauvery basin. No land acquisition is involved in this scheme. River poromboke land in SF No 1727 is available for weir and water spread area.

- 3. The Chief Engineer, Plan Formulation, Water Resources Department has informed that these schemes have been prepared based on the Schedule of Rates for the Year 2021-22 and requested to accord Administrative Sanction for the proposal for Construction of 5 Nos. of Check Dams in Coimbatore Region for an amount of Rs.22.15 Crore.
- 4. In the letter second read above, the proposal of the Chief Engineer, Plan Formulation, Water Resources Department for the above Check Dams have been forwarded to NABARD for loan assistance under RIDF XXVII for the year 2021-2022 at a restricted cost to Rs.21.82 Crore.
- 5. The Government, after careful examination, have decided to accord sanction for the proposal of the Chief Engineer, Plan Formulation, Water Resources Department at a cost of Rs.21.82 Crore in anticipation of loan assistance from NABARD. Accordingly, sanction is accorded for the

construction of the following 5 Check dams in Coimbatore Region at an estimated cost of Rs.21.82 Crore in anticipation of loan assistance from NABARD. Out of Rs.21.82 crore, a sum of Rs.2,00,00,000/- (Rupees two crore only) is earmarked for financial year 2021 – 2022 and the balance is for the next financial years.

7. The expenditure sanctioned in para 5 above shall constitute an item of "New Instrument of Services" and the approval of the Legislature will be obtained in due course. Pending approval of the legislature, the expenditure will be met by drawl of an advance from the Contingency Fund. Orders regarding which will be issued by Finance (BG-I) Department separately. The Engineer-in-Chief and Chief Engineer (General), Water

Resources Department, Chennai is directed to send necessary proposal to Government in Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 with a copy of this order for sanction of an advance from the Contingency Fund. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimate 2021-2022 to Finance (PW-II / BG-I) Department at an appropriate time without fail. He is authorised to incur the expenditure only after obtaining approval from Legislature and concurrence of NABARD is obtained.
