ORDER:

During the Water Resources Department's Demand for Grants for the year 2021-2022 held on 23.08.2021, the Hon'ble Minister of Water Resources announced on the floor of the Assembly that "This Government demonstrated the emphasis it places on conserving and appropriately utilizing the limited water resources of the State by creating a new Ministry for Water Resources. To carry forward the vision of the Hon'ble Chief Minister, it is announced in the Budget that 1,000 Check Dams and barrages are planned to be constructed over the next 10 years"

- 2. Based on the above announcement, in the letter first read above, the Chief Engineer, Plan Formulation, Water Resources Department has sent a proposal for Construction of 4 Nos. of Check dams in Madurai Region at an estimated amount of Rs.11.65 Crore and the proposal envisages as follows:
 - I. Construction of Check Dam across the Goundanadhi in Sedapatti Village of Peraiyur Taluk in Madurai District at an Estimated amount of Rs.2.65 Crore

The proposed Check Dam site is located across the Goundanadhi river which originates on the eastern slopes of western ghats near Saptur in Madurai District. The proposed check dam lies in Gundar river basin and Upper Gundar sub basin.

II. Construction of Check Dam across the Goundanadhi in Periyakattalai Village of Peraiyur Taluk in Madurai District at an Estimated Amount of Rs.1.90 Crore

The proposed Check Dam site is located across the Goundanadhi river which originates on the eastern slopes of Western Ghats near Elumalai in Madurai district. The proposed check dam lies in Gundar river basin and Upper Gundar sub basin.

III. Construction of Check Dam across the Palar River in Kirungakottai Village of Singampunari taluk in Sivagangai District at an Estimated Amount of Rs.5.00 Crore

The proposed Check Dam site is located across the Palar River in Kirungakottai Village of Singampunari Taluk in Sivagangai District. The proposed check dam lies in Pambar - Kottakaraiyar basin and Manimuthar sub basin.

IV. Construction of Check Dam across the Kakanadhi on downstream of Railway Bridge in Sennikulam (Vayali) village of Sankarankovil Taluk in Tenkasi District at an Estimated Amount of Rs.2.10 Crore

The proposed Check Dam site is located across the Kakanadhi on downstream of Railway Bridge in Sennikulam (Vayali) village of Sankarankovil Taluk in Tenkasi District. The proposed check dam lies in Vaippar basin and Nichabanadhi sub basin.

- 3. The Chief Engineer, Plan Formulation, Water Resources Department has stated that no land acquisition is involved in these Scheme and the estimates have been prepared based on the Schedule of Rates for 2021- 2022 and requested for administrative sanction for Construction of 4 Nos. of Check dams in Madurai Region for an estimated cost of Rs.11.65 Crore.
- 4. In the letter second read above, the proposal of the Chief Engineer, Plan Formulation, Water Resources Department for the above Check Dams have been forwarded to NABARD for loan assistance under RIDF XXVII for the year 2021-2022 at a restricted cost to Rs.11.57 Crore.
- 5. The Government, after careful examination, have decided to accord sanction for the proposal of the Chief Engineer, Plan Formulation, Water Resources Department in anticipation of load assistance from NABARD. Accordingly sanction is accorded for construction of 4 Check Dams in Madurai Region at an estimated cost of Rs.11.57 Crore (Rupees Eleven crore and Fifty seven lakh only) in anticipation of NABARD loan assistance under RIDF XXVII for 2021-2022, as follows:

The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is directed to send necessary proposals to Government in Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 with a copy of this order for sanction of an advance from the Contingency Fund. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimate 2021-2022 to Finance (PW-II / BG-I) Department at an appropriate time
