ORDER:

During the Budget presented for the year 2021- 2022 on 13.08.2021, the Hon'ble Minister (Finance & HRM) had announced that "This Government will formulate Schemes to restore the reservoir capacity for important dams including Mettur, Amaravathy, Vaigai and Pechipparai. Subsequently during the Water Resources Department's Demand for Grants for the year 2021 - 2022 held on 23.08.2021, the Hon'ble Minister (Water Resources) had made an announcement that "Necessary action will be taken to restore the storage capacity of the Mettur, Amaravathy, Vaigai, Pechipparai, Gundar, Ramanathi & Willington Dams and Kaveripakkam Tank."

2. Based on the above announcement, the Chief Engineer, Plan Formulation, Water Resources Department has stated that a detailed survey on the assessment of quantity of sediments and testing for finding composition of sediments needs to be done in Willington Reservoir by engaging a qualified Consultant to prepare a proper Detailed Project Report and accordingly, he has sent a proposal for Field Study and preparing Detailed Project Report for augmenting the storage capacity of Willington Reservoir in Tittagudi Taluk of Cuddalore District" at an estimated cost of Rs.1.80 crore and stated that this field survey estimate

has been prepared based on the quotation received from M/s Wapcos Limited who are reputed and qualified Consultant in preparing Detailed Project Reports for such desilting works and requested to accord Administrative Sanction for "Field Study and preparing Detailed Project Report for augmenting the storage capacity of Willington Reservoir in Tittagudi Taluk of Cuddalore District" at an estimated amount of Rs.1.80 crore under State Fund.

3. The Government, after careful examination, have decided to accept the proposal of the Chief Engineer, Plan Formulation, Water Resources Department and accordingly, sanction is accorded for preparation of Detailed Project Report for augmenting the storage capacity of Willington Reservoir in Tittakudi Taluk in Cuddalore District at a cost of Rs.76,70,000 (Rupees Seventy six lakh and seventy thousand only) (Rs.65.00 lakh + GST at 18% Rs.11.70 lakh). The Detailed Project Report should include the following, among other things:

- a) Demand assessment and project scoping
- b) Technical feasibility
- c) Cost- Benefit analysis in detail
- d) Environmental impact
- e) Complete legal framework
- f) Stake-holder Consultation
- g) Implementation plan
- h) Exhaustive option and scenario analysis
- i) Project resource requirement
- j) Estimate of Quantity of earth, sand and silt (beside other minerals, if any)
- k) Distance Study for major ongoing capital work of other departments and agencies such as Highways for demand assessment
- l) Other relevant matters

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

2701 - Medium Irrigation - 80 - General -
 001 - Direction and Administration -
 State's Expenditure - JI - Investigation of Projects
 on Surveying and Levelling Operations etc., -
 317 Minor Works - 01 Minor Works.

5. Necessary additional funds of Rs.76,70,000/- will be provided in Revised Estimate / Final Modified Appropriation 2022 - 2023. However, this expenditure shall be brought to the notice of legislature by way of Specific Inclusion in the Supplementary Estimate 2022 - 2023. Pending

provision of such funds, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is authorized to incur the expenditure sanctioned in para 3 above. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is directed to include the above item of expenditure while sending the budget proposal of Revised Estimate / Final Modified Appropriation 2022 - 2023 and also send necessary draft Explanatory Note for inclusion of the expenditure in the Supplementary Estimate 2022 - 2023 to Finance (PW-II / BG-I) Department at an appropriate time without fail.

6. This order issues with the concurrence of Finance Department vide its U.O. No.38359/PW-II/2022, dated.08.08.2022 and Additional Sanction Ledger No.919 (Nine hundred and nineteen) (IFHRMS ASL No.2022080919).
