



### ABSTRACT

Tamil Nadu Water Resources Department - Centrally Sponsored Scheme – PMKSY (HKKP)- Repair, Renovation and Restoration- Phase-VII - Administrative and Financial Sanction for an estimate amount of Rs.80.8293 crore for carrying out RRR works of 85 water bodies with Central State Share ratio 60 (Central- Rs.4849.76 lakhs) : 40 (State-Rs.3233.17 lakhs)- Accorded – Orders- Issued.

### ORDER:

Hon'ble Minister (Finance & HRM) has announced in the speech for RBE 2021-2022 that 200 tanks will be standardized by means of Repair, Renovation and Restoration works under PMKSY scheme for Rs.111.24 crore in the financial year 2021-2022. Besides, Hon'ble Minister (Water Resources) has announced on the floor of Legislative Assembly on 23.08.2021 during the debate on the demand of Water Resources Department for the year 2021-2022 that 200 tanks in 23 districts will be standardized under PMKSY.

2. In the G.O. first read above, the Government have accorded administrative sanction to take up 115 water bodies at an outlay of Rs.71.89 crore under Phase-VI of Repair, Renovation and Restoration Scheme under Har Khet Ko Pani component of PMKSY.

3. In the letter second read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has stated that the remaining 85 tanks are proposed under Phase-VII. The Detailed Project Reports along with estimate have been prepared as per the Schedule of Rates 2021-22. The proposals for 85 tanks for an amount of Rs.8082.93 lakhs have been approved in the State Technical Advisory Committee (STAC) meeting held on 09.02.2022 and 25.03.2022. Subsequently, the proposals were placed in the Interdepartmental Working Group (IDWG) meeting and State Level Sanctioning Committee (SLSC) meeting held on 06.04.2022 and 21.04.2022 respectively and approved for an amount of Rs. 8082.93 lakhs. Among 85

tanks, 52 tanks are under Drought Prone Areas Programme (DPAP) category and balance 33 tanks fall under Non-DPAP / General category.

4. He has also stated that the funding proposal along with all requisite authenticated certificates / documents has been sent to the Director (Mon), CWC, Chennai with a request to forward it to the Government of India, Ministry of Jal Shakti in order to include 85 water bodies under RRR scheme and release Central Assistance. The works will be taken up for execution only after the release of Central Assistance.

5. In view of above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department has requested the Government to accord administrative sanction to take up 85 water bodies at an outlay of Rs.80.8293 crore under Phase-VII of Repair, Renovation and Restoration Scheme under Har Khet Ko Pani component of PMKSY.

6. The Government have decided to accept the proposal of the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai and hereby accord administrative and financial sanction to take up 85 water bodies at an outlay of Rs.80.8293 crore (Rupees Eighty crore Eighty two lakhs and ninety three thousands only) under Phase-VII of Repair, Renovation and Restoration Scheme under Har Khet Ko Pani component of PMKSY as detailed in annexure to this Order.

7. The expenditure sanctioned at para 6 above shall be debited to the following head of account:-

**Central Share- Rs. 4849.76 lakhs**

4711 - Capital outlay on Flood Control Projects- 01 Flood Control- 103 Civil Works- Schemes shared between State and Centre - UA Repair, Renovation and Restoration of Water Bodies - 416 Major Works - 01 Major Works.

**State Share - Rs.3233.17 lakhs**

8. Necessary additional funds of Rs.80,82,93,000/- will be provided in Revised Estimate / Final Modified Appropriation 2022 -2023. However, this expenditure shall be brought to the notice of legislature by way of **specific inclusion** in the Supplementary Estimate 2022 -2023. Pending provision of such funds, the Engineer in Chief, Water Resources Department is authorized to incur the expenditure sanctioned in para 6 above. The Engineer-in-Chief, Water Resources Department, Chennai is directed to include the above item of expenditure while sending the budget proposal for Revised Estimate / Final Modified Appropriation 2022 - 2023 and also send necessary draft

explanatory notes for inclusion of the expenditure in the Supplementary Estimate 2022–2023 to Finance (PW-II/BG-I) Department at an appropriate time without fail.

9. The amount sanctioned in para 6 above shall be deposited to the Single Nodal Bank Account of the Tamil Nadu Water Resources Department as per the details given below:
