Water Resources Department - Announcement for 2021-2022 made by the Hon'ble Minister for Water Resources - Rehabilitation of Supply channels of Kottur Avarampatti Thamaraiikulam Tank at Aagaram Village of Dindigul West Taluk of Dindigul District and Rehabilitation of Ramapattinam Chinna Anicut and Peria Anicut in Pollachi Taluk of Coimbatore District at an estimated cost of Rs.5.2281 crore - Sanction accorded - Orders - Issued.

ORDER:

During the Demand for Grants for the Water Resources Department for the year 2021 - 2022 held on 23.08.2021, the Hon'ble Minister (Water Resources) on the floor of Assembly has announced that based on the types of rehabilitation works for irrigation structures and for new major schemes mentioned in the Vision document for a New Dawn for State and District level programme, 207 tanks, supply channels, ponds and their structures spread over 17 basins of 31 districts will be rehabilitated in a phased manner under NABARD assistance.

2. Based on the above announcement, the Chief Engineer, Plan Formulation, Water Resources Department in his letter first read above, has sent a proposal for the work of rehabilitation of Supply channels of Kottur Avarampatti Thamaraiikulam Tank at Aagaram Village of Dindigul West Taluk of Dindigul District and Rehabilitation of Ramapattinam Chinna Anicut and Peria Anicut in Pollachi Taluk of Coimbatore District at an estimated cost of Rs.5.30 crore and the works envisage the following:

i. Rehabilitation of the Supply channel of Kottur Avarampatti Thamaraiikulam Tank at Aagam Village of Dindigul West Taluk in Dindigul District at a cost of Rs. 4.30 Crore

The Kodaganar River originates from the hilly terrain at Athoor Village of Dindigul Taluk and Kodaganar river is one of the major tributaries of the Cauvery River and confluences with Amaravathy River. Seven Anicuts were constructed across the Kodaganar River. The Supply channel of Kottur Avarampatti Thamaraiikulam Tank off-takes from the Kodaganar Anicut. The channel is a major source of irrigation for Aagam Village. During heavy floods of 2007 & 2008, the supply channel had been damaged. Being an earthen channel, the transportation losses are more and the capacity of channel also got reduced. The beneficiary ayacut of this tank is 216 acres. Hence, it is proposed to rehabilitate this Supply channel.

ii. Rehabilitation of the Ramapattinam Chinna Anicut & Peria Anicut in Pollachi Taluk of Coimbatore District at a cost of Rs. 1.00 Crore

The Chinna Anicut and Periya Anicut were constructed across the Thalakarai Pallam in Ramapattinam, Mannur village in Pollachi Taluk of Coimbatore District. The length of the Chinna Anicut and Periya Anicut are 50 m and 65 m respectively. The Supply Channel of the Chinna Anicut irrigates 147 acres, while the supply channel of the Periya Anicut irrigates 191 acres.

The length of the supply channels of Chinna and Periya Anicuts are 2000 m and 4000 m respectively. These Anicuts are in damaged condition with leakages in the body wall, surplus escape and sand vent portion which need immediate renovation works. The earthen Supply channels are covered by heavy jungle and silt have to be cleared and desilted for effective irrigation. RCC trough section and PCC retaining wall are proposed in the portion when the channel passes through Black cotton soil which has more swelling pressure. Hence, it is proposed to rehabilitate the Ramapattinam Periya Anicut and Chinna Anicut.

3. The Chief Engineer, Plan Formulation, Water Resources Department has informed that the above schemes are prepared based on the Schedule of Rates for the Year 2021-22 and requested to accord Administrative Sanction for the 2 nos. of Rehabilitation works in Coimbatore Region at an estimated cost of Rs. 5.30 Crore

4. In the letter second read above, the proposal of the Chief Engineer, Plan Formulation, Water Resources Department for the above Rehabilitation works have been forwarded to NABARD for loan assistance under RIDF XXVII for the year 2021-2022 at a restricted cost to Rs.5.2281 Crore (Rupees Five crore, twenty two lakh and eighty one thousand only) in anticipation of NABARD loan assistance as follows:

5. The Government have decided to accord sanction for the above two proposals, which have been forwarded to NABARD, in anticipation of loan assistance from NABARD. Accordingly, sanction is accorded for rehabilitation of the Supply Channels of the Kottur Avarampatti Thamaraiikulam Tank at Aagaram Village of Dindigul West Taluk of Dindigul District and Rehabilitation of the Ramapattinam Chinna Anicut and Peria Anicut in Pollachi Taluk of Coimbatore District at an estimated cost of Rs.5.2281 crore (Rupees Five crore, twenty two lakh and eighty one thousand only) in anticipation of NABARD loan assistance under RIDF XXVII for 2021-2022. Further, a sum of Rs.50.00 lakh (Rupees Fifty lakh only) is earmarked for financial year 2021 - 2022 and the balance amount will be released during the next financial year based on requirements.

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-(40-01)

7. The expenditure sanctioned in para 5 above shall constitute an item of "New Instrument of Services" and the approval of the Legislature will be obtained in due course. Pending approval of the legislature, the expenditure will be met by drawal of an advance from the Contingency Fund. Orders regarding which will be issued by Finance (BG-I)

Department separately. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is directed to send necessary proposals to Government in Finance (B.G. I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1962 along with copy of this order for sanction of an advance from the Contingency Fund. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimate 2021-2022 to Finance (PW-II / B.G-I) Department at an appropriate time without fail.
