### ORDER:

During the Demand for Grants for the Water Resources Department for 2021 - 2022 held on 23.8.2021, the Hon'ble Minister for Water Resources on the floor of the Assembly had made an announcement that "The offices of the Water Resources Department are functioning in rental buildings at various places. Many offices are functioning in old buildings. Therefore, it is proposed to construct new buildings for Regular Divisions and Sub Division, Staff quarters, IHH Poondi, Quality Control Division and Sub division and Laboratories in a phased manner in 5 years"

2. Based on the announcement, the Chief Engineer, Plan Formulation, Water Resources Department has sent a proposal for Construction of Office and Laboratory Buildings for the Quality Control Divisions of the Water Resources Department at an estimated cost of Rs.3.95 crore as detailed below:

- A. Construction of an Office Building for Quality Control Division, Water Resources Department, Trichy with Head Quarter Sub Division at Trichy. Estimate amount: Rs.175.00 Lakh.

The Quality Control Division, Trichy along with Quality Control Sub Division, Trichy is temporarily functioning at the Ground Floor of the Environmental Circle Office, Trichy. The Present space is not sufficient for accommodating all the Division Office Staff, sub

division staff and Engineers of four section offices. Hence, Construction of an office building for Quality control division Trichy is necessary.

- B. Construction of an Office Building for the proposed New Quality Control Division office at Coimbatore Public Works Department Campus in Coimbatore District. Estimate amount: Rs.100.00 Lakh.

At present, the Quality Control Division Coimbatore is not having its own building and is functioning temporarily in a Water Resources Department Building, which is not sufficient to accommodate the office staff. Hence, for efficient functioning, it is absolutely necessary to construct a Quality Control Division office.

- C. Construction of an Office Building for the New Quality Control Division at Tirunelveli in Tirunelveli District. Estimate amount: Rs.120.00 Lakh.

At present, the Quality Control Sub-Division, Tirunelveli is not having its own building. Hence, it is absolutely necessary to construct a Quality Control Division office at Tirunelveli.

3. The Chief Engineer, Plan Formulation, Water Resources Department has stated that the proposals have been prepared based on the Schedule of Rates for 2021 - 2022 and requested to accord Administrative Sanction for the work of construction of Office Buildings for the Quality Control Divisions of the Water Resources Department at an estimated cost of Rs.3.95 crore.

4. The Government, after careful examination, have decided to accept the above proposal of the Chief Engineer, Plan Formulation, Water Resources Department. Accordingly administrative sanction is accorded for Construction of Office Buildings for the following Quality Control Divisions of the Water Resources Department at an estimated cost of Rs.3,95,00,000/- (Rupees Three crore and Ninety five lakh only).

Pending approval of the Legislature, the expenditure will be met by drawal of an advance from the Contingency Fund. Orders regarding which will be issued by Finance (BG-I) Department separately. The Engineer-In-Chief and Chief Engineer (General), Water Resources Department, Chennai-5, is directed to send necessary proposals to Government in Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 along with copy of this order for sanction of an advance from the Contingency Fund. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in Supplementary Estimate 2021 - 2022 to Finance (PW-II / BG-I) Department at an appropriate time.

7. This order issues with the concurrence of Finance Department vide its U.O. No. 8681/PW-II/2022, dated 28.02.2022 and Additional Sanction Ledger No.1717 (One thousand, seven hundred and seventeen)
