ORDER:

During the Water Resources Department's Demand for Grants for the year 2021-2022 held on 23.08.2021, the Hon'ble Minister of Water Resources has announced on the floor of the Assembly that "The offices of the Water Resources Department are functioning in rental buildings at various places. Many offices are functioning in old buildings. Therefore, it is proposed to construct new buildings for Regular Divisions and Sub Division, Staff quarters, IHH Poondi, Quality Control Division and Sub division and Laboratories in a phased manner in 5 years".

2. Based on the above announcement, the Chief Engineer, Plan Formulation, Water Resources Department in his letter read above, has sent a proposal for the work of construction of 14 new buildings in Water Resources Department at an estimated cost of Rs.502.85 crore and the work envisages as follows.

1. Construction of Assistant Engineer Quarters at Veppur in Veppur Taluk of Cuddalore District for Estimate Amount of Rs.43.00 Lakh

The Assistant Engineer's Quarters in Veppur Taluk of Cuddalore District was constructed in 1990. This Building was constructed with Reinforced Cement Concrete (RCC) roof. Now, the entire Quarters is heavily damaged. The rain water leaks from the roof which makes the Quarters unfit for dwelling. The newly formed Chennai – Trichy National Highway is raised for about 5 feet higher from the existing ground level. Hence, the rain water from the road side enters in to the campus and Quarters. Due to this, poisonous reptiles also comes into the Quarters which makes it unsafe to stay. So, it is necessary to construct the Assistant Engineer's

Quarters and is proposed to be constructed in Veppur Public Works Department (PWD) Campus. This estimate is prepared based on the drawing by the Chief Architect, PWD, Chennai.

2. Construction of Assistant Engineer Quarters at Virudhachalam in Virudhachalam Taluk of Cuddalore District for Estimate Amount of Rs.43.00 Lakh

The Assistant Engineer's Quarters in Virudhachalam Taluk of Cuddalore District was constructed in 1990. This Building was constructed with RCC roof. Now, the entire Quarters is heavily damaged. The rain water leaks from the roof which makes the Quarters unfit for dwelling. During rainy season, seepage in wall and leakage in roof occurs and hence Quarters is not suitable for living. So, it is necessary to construct the Assistant Engineer's Quarters and it is proposed to be constructed in Virudhachalam. This estimate is prepared based on the drawing prepared by the Chief Architect, PWD, Chennai.

3. Construction of Assistant Engineer Quarters at Keelacheruvai in Thittakudi Taluk of Cuddalore District for Estimate Amount of Rs.43.00 Lakh

The Assistant Engineer's Quarters in Tittakudi Taluk of Cuddalore District was constructed in 1990. This Building was constructed with RCC roof. Now, the entire Quarters is heavily damaged. The rain water leaks from the roof which makes the Quarters unfit for dwelling. The newly formed Trichy - Cuddalore state Highway is raised for about 5 feet higher than the existing ground level. Hence, the rain water from the road side enters into the campus and Quarters. Due to this, poisonous reptiles also comes into the Quarters which makes it unsafe to stay. So, it is necessary to construct the Assistant Engineer's Quarters and is proposed to be constructed in Keelacheruvai PWD Campus. This estimate is prepared based on the drawing by the Chief Architect, PWD, Chennai.

4. Construction of Assistant Engineer Quarters at Pelandurai Anicut Campus in Thittakudi Taluk of Cuddalore District for Estimate Amount of Rs.43.00 Lakh

The Assistant Engineer's Quarters in Pelandurai Anicut Campus in Tittakudi Taluk of Cuddalore District was constructed in 1990. This Building was constructed with RCC roof. Now, the entire Quarters is heavily damaged. The rain water leaks from the roof which makes the Quarters unfit for dwelling . During rainy season, seepage in wall and leakage in roof occurs and hence not suitable for living. So, it is necessary to construct the Assistant Engineer's Quarters and it is proposed to be constructed in Pelandurai Anicut PWD Campus. This estimate is prepared based on the drawing prepared by the Chief Architect, PWD, Chennai.

5. Construction of Assistant Engineer Office at Veppur in Veppur Taluk of Cuddalore District for Estimate Amount of Rs.39.60 Lakh

The Assistant Engineer's Office of Irrigation section Veppur, in Veppur Taluk of Cuddalore District was constructed in 1990. This Building was

constructed with RCC roof. Now, the entire Quarters is heavily damaged. The rain water leaks from the roof which makes it unfit for usage. The newly formed Chennai – Trichy National Highway is raised for about 5 feet higher than the existing ground level, so the rain water from the road side comes into the campus and enters into Office. Due to that, poisonous reptiles also comes into the Office which makes it unsafe. So, it is necessary to construct the Assistant Engineer's Office and it is proposed to be constructed in Veppur PWD Campus. This estimate is prepared based on the drawing by the Chief Architect, PWD, Chennai.

6. Construction of Irrigation Section WRD Office Building, Cheyyar Town at Section Office Quarters Campus in Cheyyar Taluk of Thiruvannamalai District for Estimate Amount of Rs.17.55 Lakh

The Section Office is situated in Cheyyar town near Municipality office of Cheyyar town in Cheyyar Taluk of Thiruvannamalai District. Thandarai Anicut system Main canal 20.205 Km, Thandarai system tanks 10 Nos, Non system tanks 14 Nos and Cheyyar Anicut system tanks 15 Nos, are functioning under the control of this section office.

The existing section office building is fully damaged and not fit for office use. Hence, it is proposed to construct new section office building in Cheyyar at Junior Engineer's Quarters complex, Cheyyar town.

It is proposed to provide land space for construction the Section office buildings in the existing space available in Junior Engineer Quarters complex, Cheyyar town. This estimate is prepared based on the drawing by the Chief Architect, PWD, Chennai.

7. Construction of Irrigation Section WRD Office Building, Cheyyar Anicut at Cheyyar Anicut Inspection Bungalow Campus in Cheyyar Taluk of Thiruvannamalai District for Estimate Amount of Rs.17.55 Lakh

The existing Section Office is situated at Arani to Vandavasi Main road near Cheyyar Anicut situated near Pillandhi Village in Cheyyar Taluk of Thiruvannamalai District. Under the control of this Cheyyar Anicut section, there is one anicut (Cheyyar Anicut), Cheyyar Anicut Main canal, 23 system tanks and 5 Nos of Non system tanks and maintained by this section.

The existing section office building is fully damaged and not fit for any office use, Hence it is proposed to construct new section office building in Cheyyar Anicut at Cheyyar Anicut Inspection Bungalow Campus near Pillandhi Village in Cheyyar Taluk.

It is proposed to provide the New space to the Section office of the above building in the existing space available in Cheyyar Anicut Inspection Bungalow Campus near Pillandhi Village in Cheyyar Taluk and this estimate is prepared based on the drawing by the Chief Architect, PWD, Chennai.

8. Construction of Irrigation Section WRD Office Building, Peranamallur at Peranamallur WRD Campus in Vandavasi Taluk of Thiruvannamalai District for Estimate Amount of Rs.17.55 Lakh

The existing Section Office is situated at Peranamallur to Chetpet road in Vandavasi Taluk of Tiruvannamalai District. 40 Nos, of Non system tanks are maintained by this Peranamallur section office.

The existing section office building is fully damaged and not fit for office use. Hence, is proposed to construct new WRD section office building, Peranamallur at Peranamallur WRD Campus in Vandavasi Taluk of Tiruvannamalai District.

It is proposed to provide the Land space for the Section office buildings in the existing space available at Peranamallur WRD Campus in Vandavasi Taluk. This estimate is prepared based on the drawing by the Chief Architect, PWD, Chennai.

9. Construction of Irrigation Section WRD Office Building, Kovilur at Kovilur Inspection Bungalow Campus in Cheyyar Taluk of Thiruvannamalai District for Estimate Amount of Rs.17.55 Lakh

The existing Section Office is situated Cheyyar to Vallam road near Kovilur Village in Cheyyar Taluk of Thiruvannamalai District. Cheyyar Anicut Main canal, 5 Nos of Regulator, 43 Nos of Cheyyar Anicut system tanks and 2 Nos of Non system tanks are maintained by this section office.

The existing section office building is fully damaged and is not fit for office use. Hence, it is proposed to construct new section office building in Kovilur Inspection Bungalow Campus, Kovilur Village in Cheyyar Taluk.

It is proposed to provide the Land space for the Section office building in the existing space available in Kovilur Inspection Bungalow Campus, Kovilur Village in Cheyyar Taluk. This estimate is prepared based on the drawing by the Chief Architect, PWD, Chennai.

10. Construction of Irrigation Section WRD Office Building, Veerambakkam at Veerambakkam Inspection Bungalow Campus in Cheyyar Taluk of Thiruvannamalai District for Estimate Amount of Rs.17.55 Lakh

The existing Section Office is situated in Vandavasi to Kanchipuram main road near Veerambakkam Village in Cheyyar Taluk of Thiruvannamalai District. 47 Nos of Cheyyar Anicut system tanks are maintained by this section office.

The existing section office building is fully damaged and not fit for office use. Hence, it is proposed to construct new section office building in Veerambakkam Inspection Bungalow Campus, Veerambakkam Village in Cheyyar Taluk.

It is proposed to provide the Land space for the Section office buildings in the existing space available in Veerambakkam Inspection Bungalow Campus, Veerambakkam Village in Cheyyar Taluk. This estimate is prepared based on the drawing by the Chief Architect, PWD, Chennai.

11. Construction of Irrigation Section WRD Office Building, Kurinjipadi Taluk of Cuddalore District for Estimate Amount of Rs.25.50 Lakh

The existing Section Office is situated in Kurinjipadi Division is in dilapidated condition and is not in use. This division maintains 18 tanks, 5 Anicuts and other irrigation canals to irrigate nearly 1438.19 Ha land. Hence, it is essential to construct a new section office for Kurinjipadi Division. Also for safety reasons, compound wall for 100 m is proposed. This estimate is prepared based on the drawing by the Chief Architect, PWD, Chennai.

12. Construction of Section office at Keelacheruvai village in Thittagudi Taluk of Cuddalore District for Estimate Amount of Rs.40.00 Lakh

Section Office of Irrigation section Keelacheruvai, in Tittakudi Taluk of Cuddalore District was constructed in 1990. This Building was constructed with RCC roof. Now the entire Office Building is heavily damaged. The rain water leaks from the roof which makes it not useable. The newly formed Trichy – Cuddalore National Highway is raised for about 5 feet higher than the ground level, so the rain water from the road side comes into the campus and enters into Office. Due to that, poisonous reptiles also comes into the Office which makes it unsafe. So, it is necessary to construct the Section Office with compound wall of length 25 m and is proposed to be constructed in Keelacheruvai PWD Campus is prepared based on the drawing by the Chief Architect, PWD, Chennai.

13. Construction of Section office at Pelandurai campus in Thittagudi Taluk of Cuddalore District for Estimate Amount of Rs.40.00 Lakh

Section Office of Irrigation section Pelandurai, in Pelandurai Anicut Campus in Kosapallam Village of Tittakudi Taluk of Cuddalore District was constructed in 1990. This Building was constructed with RCC roof. Now the entire Office Building is heavily damaged. During rainy season, leakage occurs and hence inconvenience is caused. So, it is necessary to construct the Section Office and it is proposed to be constructed in Pelandurai Anicut Campus is prepared based on the drawing by the Chief Architect, PWD, Chennai.

14. Construction of 1 Assistant Executive Engineer Quarters and 2 Assistant Engineer Quarters and Irrigation Assistant Quarters in S.V. Nagaram village in Arni Taluk of Thiruvannamalai District for Estimate Amount of Rs.98.00 Lakh

Sub-Division office at Arni maintains 173 tanks, 22 Anicuts. Under this Sub-Division, Irrigation section 1 & 2 are functioning . The existing Quarters for AE and Irrigation Assistant was constructed during British time and is in damaged condition. Hence, it is essential to construct Quarters for AEE, AE and Irrigation Assistant. The estimates are prepared based on the Drawing prepared by the Chief Architect, PWD, Chennai.

3. The Chief Engineer, Plan Formulation, Water Resources Department has informed that all the above schemes are prepared based on the Schedule of Rates for the Year 2021-22 and requested to accord Administrative Sanction for the proposal for "Construction / Reconstruction of 14 Nos. of Buildings" for an estimated amount of Rs.502.85 lakh.

4. The Government, after careful examination, have decided to accept the proposal of the Chief Engineer, Plan Formulation, Water Resources Department restricting the cost of the works to Rs.4,96,78,000. Accordingly, sanction is accorded for Construction of the following 14 new Staff Quarters and Office Buildings for the Chennai Region of Water Resources Department at an estimated cost of Rs.4,96,78,000/- (Rupees Four crore, Ninety six lakh and Seventy eight thousand only) :

Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules, 1963 along with copy of this order for sanction of an advance from the Contingency Fund, orders regarding which will be issued by Finance (BG-I) Department separately. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in Supplementary Estimate 2021 - 2022 to Finance (PW-II / BG-I) Department at an appropriate time.
