ORDER:

During the Water Resources Department demand on 23.08.2021, the Hon'ble Minister for Water Resources has announced in the floor of Assembly that "New vehicles will be given to the officers of Water Resources Department by replacing the old used vehicles over a period of three years in a phased manner".

2. Based on the above Announcement the Chief Engineer, Operation and Maintenance, Water Resources Department has prepared and sent the estimate for "Purchase of new vehicles as a replacement for old used vehicles to the officers of Water Resources Department over a period of three years" for an amount of Rs.12.90 crore spanning over a period of three years.

3. In the estimate the provision made to purchase Vehicles within three years duration are as follows:

- First year – 2021-22 – to purchase 2 Nos. of cars for Chief Engineers, 3 Nos. of cars for Superintending Engineers and 71 Nos. of jeeps for Executive Engineers and Assistant Executive Engineers of Water Resources Department.
- Second year – 2022-23 – to purchase 40 Nos. of jeeps for Executive Engineers and Assistant Executive Engineers of Water Resources Department.
- Third year – 2023-24 – to purchase 40 Nos. of jeeps for Executive Engineers and Assistant Executive Engineers of Water Resources Department.

4. The financial breakup for 3 years is as follows:-

6. The Chief Engineer, Water Resources Department, Plan Formulation has therefore requested the Government to accord in-principle approval for an amount of Rs.12.90 crore for purchase of new vehicles as a replacement for old used vehicles to the officers of Water Resources Department over a period of three years and Administrative Sanction for an amount of Rs.6.1370 crore for the year 2021-2022.

7. The Government after careful consideration decided to accept the proposal of the Chief Engineer, Plan Formulation, Water Resources Department, Chennai and accord in-principle approval for an amount of Rs.12.90 crore for purchase of new vehicles as a replacement for old used vehicles to the officers of Water Resources Department over a period of three years and Administrative and Financial Sanction for an amount of Rs.6.1370 crore (Rupees Six crore thirteen lakh and seventy thousand only) for the year 2021-2022.

8. The expenditure sanctioned at para 7 above shall be debited to the following Head of Account:

"2059 Public Works – 80 General – 105 Public Works Workshop – States' Expenditure – AD Workshop Establishment – 321 Motor Vehicles – 01 – Purchase".

9. The expenditure sanctioned in para 7 above shall constitutes an item of "New Instrument of Services" and the approval of the Legislature will be obtained in due course. Pending approval of legislature, the expenditure will be met by drawl of an advance from the Contingency Fund. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is directed to send necessary proposals to Government in Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 with a copy of this order for sanction of an advance from the Contingency Fund. Orders regarding which will be issued by Finance (BG-I) Department separately. He is also directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimate 2021-22 to Finance (PW-II / BG-I) Department at an appropriate time without fail.

10. Further, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai is directed to condemned the existing old vehicles within 30 days.

11. This order issues with the concurrence of Finance Department vide its U.O. No.05 / DS / AR / Fin (BG-II) / 2022, dated 07.01.2022 and Additional Sanction Ledger No. 1394 (One thousand three hundred and ninety four)
