Sub: Water Resources Department – Formation of **Emergency Flood Response Team (WRD – EFRT)** - Flood and the other natural calamities - reg

Ref: This office Lr.No. AEE/AE1/ T1 / F- General / 2024 dated 10.10.2024.

In the light of the onset of North East Monsoon, the Department has formed the Formation of Emergency Flood Response Team (WRD – EFRT) by nominating the officers in the list enclosed to engage in the flood relief duty to ensure effective coordination for relief efforts.

Roles and Responsibility of the nominees:

- 1) To coordinate for Flood restoration works and support to the affected areas.
- 2) The nominated officials, upon receipt of the orders / instructions from the Engineer-in-Chief and Chief Engineer (GI), WRD are requested to report the designated Nodal officer in the area impacted by significant flood / other natural calamities. In such instance, these nominated officials should arrive at the designated site in a timely manner to support and execute the flood related restoration rescue by coordinating with local WRD officials.
- 3) To give necessary technical guidance to restore the flood affected area as early as possible to bring the normality.

- 4) To work in coordination with a team spirit to ensure safety of the structure from potential breach and secure the Irrigation and water supply systems.
- 5) To ensure Safety and wellbeing of the Public by collaborating with the local authorities and relief teams.
- 6) It is also informed that the period of absence in the headquarters of the concerned nominated officials engaged in this specific flood relief works shall be treated as official duty and the nominated officials are eligible to draw Travelling Allowance and Dearness Allowance related to their travel for this specific relief works at the rate admissible as per rules in force.


Hence, the respective Chief Engineers are requested to instruct the nominated officials (list enclosed) to prepare themselves for attending the Flood relief duty on receipt of necessary orders from the Engineer-in-Chief and Chief Engineer (GI), WRD.
